ADVISES & QUERIES: TENTH MONTH ~ PERSONAL RELATIONSHIPS

In daily relationships with others, both inside and outside the home, our lives as Friends speak immediately and lastingly. In these relationships, our faith may also be severely tested. We are called to respond to that of God in everyone: we are all children of God. Friends celebrate any union that is dedicated to mutual love and respect, regardless of the unique make-up of the family. We strive to create homes where the Spirit of the Divine resides at the center and where the individual genius of each member is respected and nurtured.

Human sexuality is a divine gift, forming part of the complex union of body, mind and spirit that is our humanity. In a loving adult relationship in a context of mutual responsibility, sexuality brings delight, fulfillment and celebration.

The presence of children carries a special blessing as well as responsibility. Children bring unique spiritual gifts — wonder, resiliency, playfulness and more. Recognize and honor the Divine Light within children and treat them with the dignity and respect that is due to all people. Listen to and learn from children; share with them those values and practices that are central to our own lives. Special care must be given to resolving problems between adults and children in a manner that gives equal weight to the feelings and needs of both children and adults. Tender parenting is one of the critically important peace vocations in our society. Make every effort to offer all parents the personal and institutional support that this challenging work requires.

Take a strong stand against any form of abuse, whether that abuse is minor or severe, and whether it is emotional, physical or sexual in nature. WOOLMAN AND CHIRP MADE IT HAPPEN October 1, 2024

Escrow has closed, title has transferred! Here is a collaborative press release from CHIRP and the Woolman team...

The California Heritage: Indigenous Research Project (CHIRP) and the College Park Friends Educational Association (CPFEA) AKA Woolman are deeply proud to announce their successful endeavor to transfer 232 acres and the site of the John Woolman School into the hands of CHIRP and the Nevada City Rancheria (NCR) Nisenan Tribe. The escrow completed on September 27, 2024 and was the result of significant and inspired effort of all parties.

The land, located on the historic Nisenan village site of Yulića, will once again become a landbase for the Tribe—and provides an opportunity for the NCR Nisenan Tribe to reclaim a piece of their land-based ceremonial and Cultural practices, Elder housing, and renewal of the Tribe's relationship with their Ancestral Homelands and its more-than-human kin.

For the past sixty years, Woolman has used the property to operate Quaker-based educational programming, including a residential high school, a semester school for high school juniors and seniors, outdoor school and after-school programs, summer camps for youth, and educational experiences for adults on topics such as activism, the arts, peace, justice, environmental sustainability, and personal and spiritual growth. In the last few years, due to both the Covid pandemic halting in-person programs and the Jones Fire which incurred unexpected costs, Woolman could no longer sustain its programming, and began to look for a way to transition the property to new hands consistent with its mission and values. The Woolman board asked themselves, "Is there something good that could come from our loss?"

The Woolman board and staff had already been participating in their own internal process of coming to terms with the history of the land they occupied, including the Indigenous Peoples who called that land home, the legacy of colonialism that violently dispossessed those communities, and the land theft and commodification that ensued and led to current day "ownership." Guided by the belief that the land is Sacred and that restoring "ownership" into the hands of the original stewards was most consistent with the values upheld by Woolman, the Woolman board reached out and began interfacing with CHIRP, who confirmed a commitment to the site. A few years later in Fall of 2023, formal conversations about a land transition emerged between the Woolman board and CHIRP, and an exclusive "discount sale" negotiation between the non-profits began. Nisenan Land Acknowledgment

We acknowledge the Nisenan people are still here among us today, though they are nearly invisible, and their story continues to be excluded from history.

We understand we are on Nisenan land that was never ceded, and the original tribal families have yet to recover from the near genocide of their people.

As a resident or visitor in Nisenan land, we support the Nevada City Rancheria Nisenan tribe in efforts to stabilize their people as well as the campaign to restore tribal sovereignty through federal recognition.

OUR WORDS MATTER

From Bishop White: Our Words Matter – Speaking Up Against Hate in Springfield

September 16, 2024

People of God in Southern Ohio,

As people of God, we know that our words matter. Our stories matter. In our baptism, we promise to proclaim by word and example the Good News of God in Christ, and to respect the dignity of every person. When we go into the world, we seek and serve the marginalized, drawing our circle ever wider, knowing that Jesus calls us unequivocally to love our neighbor as ourselves.

Over the last several days, because of hate-filled words and fabricated stories, the community of Springfield, Ohio has been thrust into the national spotlight, prompting a barrage of racist threats against our Haitian neighbors. Let me be clear: these stories are fearmongering and admitted lies. These dangerous falsehoods have resulted in a tense moment of palpable racism, bomb threats that have shut down schools and workplaces, and the cruel politicization of one child's tragic death.

Over the past week, I've been in conversation with the Rev. Michelle Boomgaard, Ph.D., rector serving Christ Church, Springfield, and am deeply grateful for her leadership. United with other faith leaders in Springfield, they have been strong in their witness against hate and calling the community toward compassionate welcome. They offer these ways to take action in support of the Haitian community in Springfield and in our own communities:

- Stop spreading misinformation and memes. The situation in Springfield is dangerous, and joking about it only exacerbates the tension on the ground and gives credibility to the conversation.
- Engage Haitian businesses. With the barrage of bomb-threats and other abuse, utilizing our neighbors' businesses can mitigate the effects of unforeseen closures and other safety provisions.
- Join me in giving to Springfield's <u>Haitian Community Help and Support Center</u>, a nonprofit by and for Haitians, helping to connect neighbors with local services and support networks.
- Act locally to support immigrants of all backgrounds in their transition to this new country, making clear our call to welcome the stranger in our midst.

Friends, as Episcopalians in Ohio, we must stand strong and use the words and stories Jesus taught us. Together, we can confront this hate with love, this fear with compassion, these words of evil with the words of the Good News: that the way of Jesus is the way of God's boundless and never ceasing love.



HOW WE WORK IN PARTNERSHIP: The Power of Right Sharing Right Sharing of World

Resources (RSWR) currently has two focus areas: "Right Relationship" and "Right Sharing." Right Sharing work forms, trains, and funds women's groups around the world through global partnerships that transform communities. The funds are shared with the partner communities in the form of micro-grants that stay within them. Led by Country Coordinators who are from the partner communities, the program invests in relationship building and training, and works exclusively with women's groups, rather than with individuals.

The cohesion of these groups is vital to community transformation. It is the women as a team who support each other in their enterprises, save money in a group for personal emergencies, and create the social structure that enables the loans to be repaid and re-loaned to other women. Micro-loans to individuals, which do not offer this level of support, have a high rate of default. In Right Sharing's mode of operation, the women identify, with the support of the Country Coordinators, areas of need in their communities and then address those needs.


Three common themes for community needs are increased access to education, food, and safe transportation. Women's groups have sold healthy food in their communities at critical access points and arranged for transportation and uniforms for school-aged children. The power of the group, and the group's determination of how best to run its enterprises, are key components of RSWR's program.

Funds granted to partner groups never return to RSWR. Instead, the grants go into the coffers of the women's groups and then are distributed to the women in the form of micro-loans, which have an attached rate of interest that protects the money from the effects of inflation.

In the countries with which we partner, personal or small business loans are difficult, if not impossible, to obtain. Moreover, the typical interest rates on loans are extremely high, sometimes up to 20%, and the loans may be offered by moneylenders who entrap people when the bills cannot be paid on time. Loaning money is not, however, the most important thing about the women's groups: self-determination and group cohesion are more vital to a group's ongoing success. Country Coordinators offer training on self-esteem, small business, money management, group dynamics, and access to government services that strengthen communities in a lasting way. <u>LEARN MORE</u>.



Cary Memorial Lecture, Bridget Moix shares lessons, laughter, and Light from her journey with Friends toward becoming the beloved community we seek.



Pendle Hill Pamphlet #489 (October 2024)

Synopsis

Many Quakers are grappling with leadings for racial reparations and a deeper commitment to anti-racist awareness and action. Reparations must begin with an adequate grasp of Quakers' direct involvement in chattel slavery and white supremacy. From 1657 to 1758, Quakers did not act decisively to end the hypocrisy of valuing equality, plainness, and peace, while simultaneously profiting from the slave trade and human misery. What rationalizations did Friends use to justify the continuation of enslaving and slave trading? What racist thoughts undergirded resistance to manumission? In what ways did Quaker governance fail to end Quaker complicity with slavery? Integrating this erased history will aid our efforts at racial reparations and the development of anti-racist awareness and actions. Discussion questions are included.
