ADVISES & QUERIES: ELEVENTH MONTH ~ Social and Civic Responsibility

In the words of William Penn, "True godliness don't draw men out of the world, but enables them to live better in it and excites their endeavors to mend it." Elsewhere he commented: "It is a reproach to religion and government to suffer so much poverty and excess.

Poverty within a wealthy society is unjust, cruel, and often linked to skin color, gender, and language. We must examine our own privilege and role in the economic order that deepens this disparity. Friends should be alert to oppression and injustice, and persistent in working against them.

We value our part in shaping the laws of our country. Our task is to see that laws serve God's purposes and build a just social order. Our first allegiance should be to God, and if this conflicts with any compulsion of the state, we serve our country best by remaining true to our higher loyalty.

If, by divine leading, our attention is focused on a law that is contrary to God's law, we must proceed with care. Before acting, Friends should pray for further guidance and speak with the Meeting, family members, and all those who might be affected by the decision. If a decision involves disobedience to the law, we should make the grounds of our action clear to all concerned and be prepared to suffer any penalties without evasion. As a community, we must care for those who suffer for conscience's sake.

What am I doing to carry my share of responsibility for the government of our community, nation, and world?

Am I persistent in my efforts to promote constructive change?

How do we attend to the suffering of others in our local community, in our state and nation, and in the world community?

Do we try to understand the causes of suffering, and do we address them as a Meeting?

How do we, individually and as a Meeting, support the organizations that work to bring the testimonies of Friends into reality in our society?

Treasurer's Report, 11-10-2024

Summary = not a bad year, but short of our goals

This report covers July through September 2024, and the Fiscal Year 2023 – 2024. The contributions for the last quarter (\$2,252) generally kept up with our monthly expenses, but did not provide the funds necessary for making our year-end contributions. In keeping with the Meeting's policy of contributing only what is funded by the contributions of the current year, we did not make any of these contributions for FY 2023-2024 (except for a \$500 contribution to the Nisenan, which was \$375 more that the budgeted \$125 contribution).

Our shortfall this Fiscal Year is closely related to three factors. The first is the need to purchase a new computer and software for the Treasurer (\$690). Second is the need to rebuild our website (\$1,200). And finally, our very generous contribution to the Nisenan land rematriation (\$5,500). Although this final amount did not come out of the General Fund, it certainly impacted our member's and attender's ability to contribute overall. None of these three events are expected to occur again.

The "Fund Balances" and the "Actual Spending vs Budget" reports are available in the Meeting House – near the library – and by contacting me.

THE RELATION OF TRUTH TO PEACE – InterFaith Nevada County

"What wisdom can you find that is greater than kindness?" asked the philosopher Rousseau, centuries ago. Indeed, every belief system embraces principles such as the Golden Rule--doing unto others as you would like done unto you, or even the Platinum Rule – do unto others as they would want done to them. Humans share a foundational desire for respect, along with the obligation to respect others in return.

We show respect by speaking truthfully as well as kindly. We all learned this basic moral code in kindergarten. Our words and actions matter, as the building blocks of our character and, ultimately, of our nation. Recently, this simple wisdom seems forgotten. Whether at the local level, as people express their views in opinion pieces or social media posts, or at the national level, in political rallies, town halls, or campaign statements, scoring a point can supersede the goals of kindness and truthfulness. Where there is no concern for truth, there follows no concern for the well-being of others. This pattern leads to hate in speech or action and a lack of security and safety for us all.

In these days leading up to the election, and in the months and years that follow, let's return to the values and norms that have sustained every long-lived civilization. We encourage all people to recommit to the decency of speaking truthfully and kindly, of acting in a way that reflects all the great wisdom traditions. In our hearts, we know what is right and true. Let us agree to do better going forward, for the sake of our own integrity and peace of mind and for greater peace in the world, remembering that these aspects of peace happen to be one and the same.

Feel the fear, but go beyond the fear to grief and holy, alchemized rage and love, the kind of love that sears your heart and allows you to let go of the fear and walk with the clarity that our spiritual selves hold magic, that with truth and love we can transform into vessels that can create the world we can taste, that sweet world we can taste. Hate and white rage are fires that burn fast and hot, and maybe we won't make it out alive, we surely won't but with the clarity that our lives are living prayers for the world we need, with a sense of solidarity in our mutual vulnerability we can make refugia for one another and plant the deepest seeds into the earth of what is our birthright, to know and live from deep consciousness that we are one. This is not easy work, to alchemize fear and pain, community is necessary, and it is the work calling us to let this moment be a teacher that changes us and leads us into the next faithful step.
