MINUTES & RECORD: Meeting for Worship on the Occasion of Business, February 9, 2025

We met in a hybrid meeting in person at the meetinghouse and on Zoom.

The Meeting opened with silent worship.

Clerks' Remarks and Query

- Micah 6:8: Do justice, love mercy, and walk humbly with your God.
- Query: How do you see Meeting for Worship for Business, and this process, assisting or guiding you as you attempt to live out the request from Micah to "do justice, love mercy, and walk humbly with your God."
 - Friends spoke out of the silence:
 - One Friend recalls another friend who recommended a two-step approach to Quaker Bible study: 1. Try to understand what the scripture/quote meant at the time, who was saying it, and who it was being said to. 2. What does it mean to you today? This Friend says our quote is meaningful to him today.
 - O Another Friend shared that Meeting for Worship for Business is not about making decisions. It is about loving one another. We can be present, not just for the issue, but for all the hearts in the room. To "speak and release" requires such humility but it needs to be paired with love. Do our process with love and release it outward.
 - Justice, when done in love, is "just us."
 - Another Friend recalled her work with treatment courts that recreate a family with love, and not throwing anyone away. Take a breath. Let's wait a second before we react. Even after pain and trauma, we can use our Quaker process to heal and come together with love.
 - Another Friend remembered how children can be guided to come together and find unity.
 - Too often "justice" is used to mean "retribution" or punishment. Everyone needs to be involved.
 No one should be left out. When we work as activists, we are working to make sure everyone is included in our government structures, and no one is left out.
 - One Friend expressed a personal concern about how we take these Quaker ideas and Quaker processes and bring them out to the concerns of the world?
 - O Sometimes "walking humbly with your God" means you don't know the way forward, but you continue forward steadfastly, knowing you will be guided.
 - Another Friend is sitting with a concern about our Quaker process. What happens when a weighty concern is brought to Meeting for Worship for Business and a decision is made when you know people who feel strongly on the other side, or are affected by the decision, are not in attendance? Do we go forward and make the decision as is the process, or do we wait and include the people who are affected by the decision? Several Friends spoke to this about extending an opportunity for participation is both justice and mercy. If justice does not include everyone, it might be "just us" in the justice system.
 - Tyrants draw their power from people's fear. If we don't buy into the fear, they don't have the power. We need to have passive INSISTENCE, not just resistance.

Sharings from the wider Quaker world:

- There are Quaker Meetings that have filed suit against the change in government policy allowing ICE officers into places of worship, hospitals, and schools. Dianne has several articles that she will include in the newsletter. There is a Meeting tonight with members and clerks of PYM to see which other Meetings are interested in getting involved.
 - There was discussion on if we need a Minute as a meeting to go forward and support PYM being named in this lawsuit?
 - There was a lot of discussion on two separate issues: how to handle the call to the meeting this evening with PYM on this issue, and if we should create a minute in support.
 - There was concern about sharing the email on the email tree, when it is supposed to be discrete. Friends agree that not every member needs to attend. Our clerk can go on our behalf.
 - Friends agreed that there should be a formal Minute so we, as a meeting, are on record for supporting action on this issue.
 - O There were questions about whether we support PYM being named, or support the discernment and decision made by PYM going forward. One Friend brought up that much discernment has already been done by other Quaker meetings already involved in the lawsuit. Several Friends agreed that we should say that we support Pacific Yearly Meeting being named and take a stand against the government's action.

We acknowledge the Nisenan people are still here among us today, though they are nearly invisible, and their story continues to be excluded from history.

Message from Dodie Johnston, January 16, 2025

News of former Co-Clerk of Grass Valley Friends Meeting

Dear ones: Carol Fuller spent Thanksgiving with her Grass Valley family this year and she and I returned to Ajijic, Mexico, together November 30. She seemed exhausted by the whole flight experience, but in otherwise good health. The following day she complained of a cold, which became a "lung infection" according to her local naturopath. Then came the antibiotics, which upset her digestive system and didn't cure the infection. Then she became dehydrated, etc, etc. etc.

I found the diagnostic process between then and now very frustrating and alarming and kept suggesting returning to the States for a clearer treatment plan. But you know how deeply Carol was committed to her Unity/Course in Miracles belief system and was determined to THINK herself well, so she resisted all suggestions to activate her SkyMed insurance and fly home. The Namaste community of which Carol is a member, believe similarly, so the endless CAT scans and, blood tests and ultra-sounds continued with no specific diagnosis rendered and nobody pressing for one because they were toning and tapping and thinking her well.

Now (1/16/2025) her daughter, Kara, is at her bedside in Ajijic, and Carol is within a day or two of death. I cannot tell you of what. I thought you would want to know that she is leaving us and might want to send your thoughts and prayers in whatever way you do to speed her on her way. Nancy, remember when she said "I'll die in Mexico" when we last visited at your home in co-housing? Well, even though she said she was not ready then, she is now. Please pass this news on to anyone who you know loves Carol and wants to know Love to all of you, Dodie

The message comes from a trusted name or source with a dubious request. Example:

- 2. Thanks! Here's what I want you to do for me because I'm a little busy right now. I have been working on incentives and I aimed at surprising some of our diligent members with gift cards. I will reimburse you. This should be confidential until they all have the gift cards as it's a surprise and you will keep one for yourself too.
 - Can you get this done? Dorothy Henderson clerk.
- 3. On Feb 10, 2025, at 12:00 PM, Dorothy Henderson < quakerismcenter666@gmail.com > wrote:

I will be glad if you can do this now. I need 9 qty of Sephora gift cards worth \$100 value on each (total \$900). You should get them at any local stores around you now. After you get them, I need you to remove each card from the pack and scratch the back then take a clear picture of the front and back of each card and receipt then send them to me on here in my email so I can easily get them sent to each member myself. Please keep physical cards for reference. Let me know when you are on your way to the store. Thank you.



The Black Quaker Project

In Honor of Black History Month: February was officially established as Black History Month in 1976 when President Gerald Ford recognized it as such, marking the month as a time to honor the achievements of Black Americans throughout history.



Retrospective Justice in Healing Historical Injustice and Ills: Reparations

Defined as "an attempt to administer justice years after the commission of a severe injustice or series of injustices," we advocate that Quakerism adopt Retrospective Justice as a model for healing historical injustice. Our ministry is providing education on this call to action through e-newsletters, publications, and collaborative lecture-presentations with Friend Nozizwe Madlala-Routledge, a leader in South Africa's anti-apartheid movement, the African National Congress, and transnational organizations

The Quakers of Color International Archive (QCIA)

As a study-and-research collection, our archive documents the oral histories of Quakers of Color worldwide through videotaped interviews and transcriptions. Established in 2019, the QCIA is a partnership with UMass Amherst, Haverford College, and Swarthmore College, currently housed in the W.E.B. Du Bois Library of UMass Amherst. Quakers Sue DHS over Immigration Enforcement and Religious Freedom [Updated]

Quakers are suing the U.S. Department of Homeland Security (DHS) over potential immigration raids at houses of worship. Plaintiffs include Philadelphia Yearly Meeting, New England Yearly Meeting, Baltimore Yearly

Meeting, Adelphi (Md.) Meeting, and Richmond (Va.) Meeting. The suit argues that plaintiffs' religious liberty is violated by the Trump administration's <u>January 20 rescindment</u> of protections for people without legal status in "sensitive locations" such as places of worship.

Updated 2/10/25: New England Quakers explain their participation

New England Yearly Meeting (NEYM) Secretary Noah Merrill noted that when making the time-sensitive decision to join the lawsuit he and others at the yearly meeting level discerned based on guidelines in a <u>2015</u> <u>minute</u> on responding to urgent matters.

NEYM has received support from other Christians, as well as communities of Sikhs, Muslims, and Jews, according to Merrill. Across the country, monthly meetings, yearly meetings, and other Quaker entities, have endorsed the lawsuit by adopting minutes, offering to become plaintiffs, and expressing their willingness to file amicus briefs, Merrill noted.

An amicus brief is filed by entities that are not directly involved in a lawsuit but who have a compelling interest in the outcome. MORE

Please share the story of your meeting and how you or other members doing during this time. Please share if you or others are uncertain or unable to worship due to concerns about ICE. Please also share if you are sitting in worship with new visitors or visitors who are reconnecting with the Religious Society of Friends in light of their awareness of the lawsuit.

Monthly meetings are responding to PYM's involvement in a variety of ways, such as sharing Minutes of Support. We encourage you to share how your monthly meeting is responding to the DHS lawsuit—whether through worship, fellowship, or other forms of engagement in your community.

We know there is more information that could support you—such as pastoral care resources for those who gather at your meeting, guidance on welcoming newcomers, and ideas about what else can be done. The staff of PYM will continue to gather and share information with you. Christie or Nikki are welcome you to share what would support you and any resources you require, any resources you have created, or have uncovered.
