

We acknowledge the Nisenan people are still here among us today, though they are nearly invisible, and their story continues to be excluded from history.

We understand we are on Nisenan land that was never ceded, and the original tribal families have yet to recover from the near genocide of their people.

As a resident or visitor in Nisenan land, we support the Nevada City Rancheria Nisenan tribe in efforts to stabilize their people as well as the campaign to restore tribal sovereignty through federal recognition.

MINUTES & RECORD: Meeting for Worship for on the Occasion of Business, Sunday, September 14, 2025

We met in a hybrid meeting in person at the meetinghouse and on Zoom.

The Meeting opened with silent worship.

Clerks' Remarks and Query

- Query: How are we coming together to rest for sabbath? When coming together with proposals to ponder and discern, how do you find rest? How do you observe the sabbath?
 - Friends spoke out of the silence:
 - o If we are going to meet in discernment, it is helpful to rest before getting there.
 - Being able to set your own opinions aside and instead focus on the process of discernment, seemingly insurmountable solutions can be found. Allowing the process can be a form of rest.
 - Resting into God's will, and not the details of the work, and allowing our attention to return to God's will is an ideal.
 - Resting is something we all do, animals included, when we have trust. It is trusting the process that leads to the possibility of rest.

- I find rest in releasing ideas I've had beforehand, and letting go to see where the process leads us, and as Friends share their leadings.
- Allowing us to take the time we need, and to go really slow with silence, allows us to rest and release into the safety and community that we are. It is a holy moment.
- The query and the sharings of others in our community can open up new ideas and perspectives that we might not have on our own.

Amy Cooke gave the report, appended.

- One Friend had a concern about the length of time for some of the presentations in the season of non-violence. Amy will address this concern outside of Meeting for Worship for Business.
- Another concern was about if it is comfortable for the Nisenan to invite the public onto the land here for these presentations. It was decided the tribe needs more time to settle and feel that this is a place where they get to invite people. So, these presentations have not been made public.

MINUTE 2025.09.01: We hereby release Amy and Chamba Cooke from their sojourn with the Groupe Languedoc in Congénies, France (see letter, appended). We send our gratitude to Friends there for providing another spiritual home for Amy and Chamba, and look forward to hearing more about their discernment as traveling Friends.

MINUTE 2025.09.02: Grass Valley Friends Meeting approves the Minute of Service letter for Stuart Smith.

Stewardship: Mary Starr (Clerk), Gordon Starr, Pat Phillips, Reed Hamilton, David Bowman. Dianne Marshall (ex-officio, Newsletter editor), Don McCormick (ex-officio, Librarian), Hailey Wilson (ex-officio Tech Support).

Reed Hamilton gave the report, appended. Fosten Wilson gave the budget report, appended.

- There was a question about what the word limit is for articles. Dianne will include it in the newsletter.
- There was confusion about if we were approving the budget now, or later during the treasurer's report.
- We have two separate issues, and two separate minutes. One is approving the budget for next year, and another for the use of surplus funds.

MINUTE 2025.09.03: Grass Valley Friends Meeting approves the proposed use of the surplus funds to double our out-bound donations. This is a one time change of \$1,025.

MINUTE 2025.09.04: Grass Valley Friends Meeting approves the contribution of \$500 to both the FGC and PYM/CPQM scholarship funds. This is a one time contribution out of surplus funds.

There was a long discussion about the trial meeting for worship at Peace Lutheran Church in Grass Valley.

• There was a question about why the decision was made to have a Sunday morning non-hybrid trial meeting vs. an evening meeting for worship. Stewardship found that moving the meeting and ongoing weekly worship is of higher priority to see how it works for us as a meeting.

- For the trial meeting, we would only have access to one room, so Religious Education would not be able to meet that day.
- There is a concern about not using the zoom equipment. We would want to try this before a decision is made. The hybrid could still be carried out by simply bringing a laptop which would allow Friends at a distance to still participate in the trial.
- The trial doesn't address all concerns, such as signage, etc. There are logistical and spiritual concerns here and should make sure that spiritual concerns are addressed. We have a spiritual commitment to equality. We don't want to discriminate against people who don't have a car.
- An evening meeting means we wouldn't have to notify the public of a change in location. It would keep this trial internal to our meeting. An evening meeting might exclude people who are not comfortable driving at night.
- To help visitors or members who weren't notified of the change in location, several members could be at the current meeting house to worship and guide visitors to the new location. This information can also be included in the email that goes out to the email list.
- Part of the reality of the experiment is to see what it is like to co-exist with the Peace Lutheran congregation. It will be a bumpy transition no matter what.
- The experiment means nothing will be decided yet. We would return to discern further.
- We can bring a laptop to allow this to be hybrid. It's possible to set up the equipment, if it's important to members.
- Notification would not go out on Facebook or the website.
- Music would happen before the trial meeting.
- Shelly Covert (CHIRP) has been notified.
- Spirit and Witness and Stewardship will work with all parties involved on deciding on a date.
- We want to make sure the members of CHIRP know we are grateful and that this process is not because of them.
- There would be a \$45 charge for the use of one room for the experiment.
- Any concerns about details for the experiment should be addressed to Stewardship.
- Spirit and Witness will be involved with figuring out the logistics on who will be at the current meeting house. Spirit and Witness and Stewardship will communicate with each other on the planning of this experiment.

MINUTE 2025.09.05: Grass Valley Friends Meeting will be experimenting with a single Sunday morning Meeting for Worship being held at Peace Lutheran Church in Grass Valley. We will begin with a single meeting experiment with a charge of \$45.00 for the use of one room to be used from Stewardship's discretionary funds.

MINUTE (Seasoning until 10th Month): Grass Valley Friends Meeting approves the proposed budget for the 2025-2026 fiscal year.

- It was noted that if we decide to move the meeting to Peace Lutheran Church, the rent would be a little less than we are paying now, and internet would be included.
- Also, the large donation made this year has verbally been committed for next year again.



Nonviolence in our Daily Lives Gordon Starr and Dorothy Henderson

In this program, the second in the Grass Valley Friends Meeting Season of Nonviolence, we will explore the ways in which we can begin to embrace nonviolence in our daily lives. Quakers have a long history of nonviolent activism with peace and justice issues. The current state of our country and world has led many to begin training in nonviolent action. In this program, we will take one step back and ask ourselves to explore and if possible, make a commitment in our daily lives to nonviolence of hands, hearts, and speech. Using the handout, Nonviolence as a Way of Life, we will explore how to help each other "refuse to insult our opponents," "to speak our truth with clarity," "to acknowledge our own complicity and personal responsibility for the conditions of the world." Sharing our stories, our experience, our prayers, and our vision of a nonviolent future, we will take small steps together toward building beloved community.

Nonviolence as a Way of Life

I commit to nonviolence as a way of life. To that end I will try at all times to:

- ♣ Maintain awareness that nonviolence is the foundation of the beloved community.
- Refrain from violence of hand, heart, or speech.
- ♣ Refuse to insult my opponent.
- ♣ Be open and respectful of one another, friend, or opponent, observing simple courtesy in conversation.
- **↓** Listen with my heart fully present and alert, seeking to understand.

Share my truth with clarity.

Remain humble and acknowledge my own complicity in and personal responsibility for the conditions of this world.

Offer my actions as substance for my words, and my life in service to my brothers and sisters and all my relations.

To assist in keeping these commitments I will study the lives, words, and deeds of women and men of nonviolence.

"Defending Our Democracy: Where Are We and What's Next?"

A presentation by Daniel Hunter (courtesy of Quaker Call to Action https://quakercall.net/)

Daniel Hunter makes use of careful research to describe where we are in this country with Donald Trump's use of the "authoritarian's playbook." He also outlines who is on "Team Democracy" and the nonviolent process of stopping an authoritarian coup

These are the six key elements of the authoritarian's playbook that Daniel addressed:

- 1. Direct investigations against critics
- 2. Give license to lawbreaking
- 3. Regulatory retaliation

Do try to make time to look at <u>Daniel's presentation</u> before we gather on October 5^{th.} It is about 90 minutes long. We will share his presentation and our thoughts,

- 4. Deploy military domestically
- 5. Federal law enforcement overreach
- 6. The autocrat won't leave

How have you seen Donald Trump and the current administration fit the pattern described in this playbook?

- 3. The judiciary system at all levels

- 4. Opposition political parties and grass roots
- organizations
- 5. Civil society—that's all of us!

What other players do you see now on Team Democracy? Are you called to be a player? If so, how?

Daniel outlines Team Democracy's Goals Regarding a Coup:

- 1. Slow it down.
- 2. Stop it entirely.

3. Reverse the process—restore democratic

institutions and practices...

Daniel sees us at step one.

- What do you see as the current impact of resistance and any "slowing down" of the coup?
- How do you believe local Quakers (and your meeting) might support these three steps?

Daniel's presentation had an uplifting effect on those who watched it on June 1.

- What is your overall reaction to his presentation?
- How do you maintain hope during these challenging times?
- What do you imagine as your next step to support the work of Team Democracy as an individual and as a community?

FGC GOVERNANCE REFORM

Friends General Conference is moving into a new chapter of governance.

After careful discernment, research, and prayerful listening, FGC is considering a transition from the long-standing Central Committee to a new structure: a Governing Board, a Representatives Council, and a renewed committee system. This change will allow FGC to make decisions with integrity, communicate more clearly across the community, and center Friends of Color, LGBTQ+ Friends, and younger Friends in leadership.

The Governing Board will provide oversight, fiduciary care, and spiritual grounding for FGC's work. The Representatives Council will strengthen communication between Yearly Meetings, Monthly Meetings, committees, and Friends engaged with FGC programs. Both bodies are essential to building a vibrant and inclusive future. Friends who feel led to serve on either the <u>Governing Board</u> or the <u>Representatives Council</u> are warmly invited to put their names forward.

To help shape this transition, two public listening sessions will be held on <u>September 7</u> and <u>September 11</u>. These sessions will provide space to ask questions, share concerns, and lift up hopes for FGC's future. All Friends are encouraged to participate.

INTERNATIONAL DAY (S) OF VIGILS
